the Employment Act, as follows:

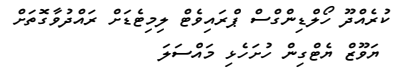
(i) 2 weeks notice to an Employee in employment for a duration of not less than 6 months to 1 year

(ii) 1 month notice to an Employee in employment for a duration more than 1 year up to 5 years.

(iii) 2 months notice period to an Employee in employment for a period of more than 5 years

(d) The termination notice period for Senior Management i-e, Grade Levels AA, A Exco, A and B is 3 months after probation, no matter the employment period.”
